#### New Business

- Look over and approve the 2023 Budget. Vote on the new budget will be held after everyone is able to look over it.
- Outstanding balance for unpaid assessments is currently \$58,470.95. Hard push for clearing up outstanding balances W11 begin in January 2023 by Lee at Bellinder Management.
- New Tax CPA voted on and approved by the board, he will be filing all Tax forms, sending out 1099s to vendors. An email will be sent by Bellinder to the previous accountant to release him from duty.
- Annual HOA meeting will be held Tuesday March 21st, 2023. If quorum is not
  met then an additional meeting will be held Thursday March 23, 2023. Thomas
  Bellinder and Lee Fanshier will be in attendance for questions.

- We got one quote to repair the Hexagonal wooden deck at Pool 1 and soffit repair on the Clubhouse. No decision was made on that quote, the question was asked if the cost of the repairs would be lower if done in the winter months versus waiting until the end of April-mid May, right before the pool opens.

  More discussion will be needed at next meeting
- Emergency/ temporary caution tape needs to be added at sidewalk/ lake area.
- Temporary caution sign with chain to be hung across steps to hexagonal deck
  warning that it is currently not safe to be walked on. Ken said he can take
  charge on that issue.
- Ken launched a new Pet registration site and posted online for homeowners to key in their pets information.
- Pool card form on the website needs to be re-checked to ensure the proper board members are getting the info and also have access to the card formatting web page. Blake and Emary will discuss this issue.
- A new calendar for the Clubhouse rental will begin to take form in January 2023 to make it easier for Lee at Bellinder Management to make sure reservations and payments are in sync.
- Grants for the Lake repair project: Lee has found a few possible grants to
  look over which each require a different list of criteria to be considered.

  Emary will get that folder so we can begin to look over the options for
  discussion at the January 2023 meeting.
- Clubhouse clean out needs to be done to get rid of old party plates, cups,
   etc. left behind by parties and events for years.
- Facebook scrub: Database of actual current homeowners will be cross examined
  to determine if all of the persons on the Laurelwood Sub. facebook page do
  still live in the neighborhood.
